## **EXHIBIT RULES AND REGULATIONS**

These terms and conditions apply to any individual or entity attending WIGA's 2021 virtual conference and exhibition ("Event") as a sponsor or exhibitor, and any individual or entity representing a sponsor or exhibitor at the Event (collectively, "Participants" and each a "Participant"). By registering for the Event, you acknowledge and agree to these terms and conditions ("Terms"). WIGA reserves the right to make changes to the Terms.

- 1. Registration and Assignment of Booth Space:** Full payment must be received at time of registration. Booths and sponsorships are not guaranteed until payment is received. Checks should be made out to WIGA and mailed to: WIGA, 525 Pear ST. SE, Olympia, WA 98501. All booth assignments will be made in accordance with sponsorship levels. In the event of conflicts or conditions beyond its control, WIGA reserves the right to rearrange the virtual floor plan. WIGA may relocate any booth at any time with the understanding that, if the Participant does not agree with the relocation then full payments for each booth will be refunded, provided the Participant chooses not to exhibit. Washington Indian Gaming Association (WIGA) reserve the right to restrict entrance into the Event by any Participant and reserves the right to remove content from virtual booths if WIGA deems such actions necessary to preserve the integrity of the event or in the best interest of WIGA.
- 2. Cancellation Policy:** A \$150 processing fee will be charged for refunds or cancellations made before May 21, 2021. Cancellations made after May 21, 2021 will receive a fifty percent refund. All refunds will be mailed to the address provided by Participant in its registration materials. All fees are non-refundable after June 7, 2021.
- 3. Exhibitor's Representatives:** Each exhibitor MUST provide a representative(s) within the exhibit space during scheduled show hours at all times.
- 4. Event Platform:** Participant understands and agrees that the Event will be hosted on X-CD Technologies platform. Accordingly, Participant agrees to comply with the X-CD Technologies terms and conditions, and any rules or regulations governing the virtual conference and exhibition. Participant understands and agrees that access to the Event and use of any related services provided by WIGA or its vendors is dependent on Participant's internet connection, hardware and certain software (including third party software) that may be required or may need updating. WIGA is not responsible for any streaming lags, interruptions, outages, or Participant's inability to access the event content as a result of Participant's internet connection or any other technical, hardware, equipment, system, server or technology related issues. Participant is responsible for their own data security while accessing the Event. Participant acknowledges that a high-speed internet connection is necessary in order to access the Online Event through a mobile network, and that Participant's network or roaming network may apply fees for data usage.
- 5. Voluntary Participation and Assumption of Risk:** Participant understands and agrees that participating in the Event is voluntary and may involve certain risks of damage to property, whether physical property or intellectual property, and other damages or losses that may be sustained by Participant, and Participant assumes all risk of damage, property loss, and/or injury which may occur as a result of participating in the Events. Participant hereby releases WIGA, WIGA's members, and each of their respective officers, directors, managers, employees, volunteers, contractors, suppliers and representatives (the "released parties") from any liability associated with participating in the Event, including liability for the negligence of any released parties, unless such liability is due to the gross negligence of the released parties, in which case the release will still apply to any of the released parties that were not grossly negligent.
- 6. Limitation of Liability:** In no event shall WIGA be liable to any Participant, or any other person or entity for any personal injury or damages to property, data loss, damages for loss of business profits or other pecuniary loss, including any direct, consequential, incidental, special, punitive or similar damages, arising out of any Participant's participation in the Event.
- 7. No Warranties:** Except as may be expressly set forth in these Terms, Participant's participation in the Event, and all services and products provided in connection with the Event, are provided "as is" without any warranty of any kind. WIGA expressly disclaims all express, implied, or statutory warranties, representations or conditions, whether written or oral, including any implied warranties of merchantability, fitness for a particular purpose, security, reliability, integration, safety, or any warranties that may arise from course of dealing. WIGA expressly disclaims any warranties not expressly stated herein and has made no representations or warranties to Participant about the suitability, condition or safety of the Event, virtual platform or digital transmission of the Event, Participants ability to access or use WIGA content or services, any equipment provided by WIGA or its vendors, WIGA services or products supplied as part of the Event or that the Event, including any streaming, will operate without interruption or be error free.
- 8. Indemnification:** Participant agrees to indemnify, defend, and hold WIGA and its members, affiliates, and each of their respective officers, directors, managers, employees, volunteers, contractors, suppliers, and representatives harmless from and against any and all claims, demands and all other liabilities, including, without limitation, costs and attorneys' fees, made by any third party arising out of or in connection with Participant's participation in the events, or any violation of the Terms by Participant.
- 9. Choice of Law and Exclusive Venue and Jurisdiction:** These Terms are governed by the laws of the State of Washington, without regard to its principles of conflicts of laws. Participant and WIGA hereby irrevocably submit to the exclusive jurisdiction of the United States federal and state courts located in Seattle, Washington including waiving any objection to personal jurisdiction, and agree that any such court will be the proper forum for the determination of any dispute arising hereunder.
- 10. Violations:** Violations of any of these Terms by Participant shall, at the option of WIGA, annul the right to participant in the Event and may be cause for having fines assessed, and such Participant shall forfeit to WIGA all monies paid. Upon evidence of a violation, WIGA may remove Participant from the Event. The Participant shall pay all such expenses and all damages that WIGA may incur and shall forfeit all monies paid or due WIGA on account thereof. The Participant waives any right to service or written notice from WIGA.
